## MEMBERSHIP RENEWALS

Memberships are due for renewal by June 30<sup>th</sup>. Please check the expiry year on your membership card.

If your membership expires on June 30<sup>th</sup>, 2024, please renew and pay online using this link:

(Note: We no longer accept paper forms. We also **DO NOT ACCEPT CHEQUES OR MONEY ORDERS.**)

## LOGBOOKS

If you require a **new logbook (i.e. the date on the FRONT COVER is 2024)**, you have 2 options:

1. You can come, in person, to the Logbook Renewal Day on Sunday 23<sup>rd</sup> June 2024. (Details on the following page.) OR
2. You can send your logbook to the club PO box (see below)

Logbooks **require endorsement by the Club** each membership year. Check the INSIDE of your logbook and see if the endorsement expires in June 2024. If it does, then it will need to be stamped after you have paid your membership. If you paid for multiple years, then your book will have been stamped for multiple years and you don't need to do anything until then.

If you only need your logbook **endorsed**, you can do the above OR:

- You can come to a club meeting and have it stamped. Note that your **membership must be paid on-line** before you attend. You won't be able to do this at the meeting.

(NOTE: Issuing NEW logbooks is NOT done at meetings).

### Posting in logbooks:

If you want to have your book endorsed or renewed by post, please do the following:

- Post your expired book to the Chrysler Car Club of SA, PO Box 240, GREENACRES, SA, 5086.
- You must include a stamped, self-addressed envelope with your logbook, so we can return your new book.
- DO NOT use registered mail. If you want to track your mail, use Express Post envelopes (we don't have to go into the post office to collect Express Post letters as we don't have to sign for them like we do with registered mail).
